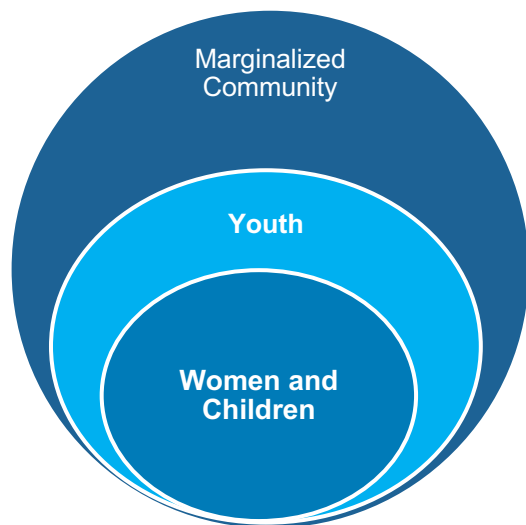

## Child Development and Education



Quality and inclusive public education and child development is one of the major themes of PeaceWin Nepal. It ensures the best interest of the children through its strategic principles. In 2025, in collaboration with Plan International Nepal, Good Neighbors International (GNI), and United Nations Population Fund (UNFPA), various programs have been implemented at local and provincial level to improve access to quality and inclusive education, prevention of child marriage, promotion of child rights, and strengthen child-friendly local governance systems. The organization has supported teaching-learning aids, establishment of reading corners at home, and adolescent-friendly information

corners in schools. The programs focus on teachers and school management committees' capacity building through training, workshops and excursion on inclusive and gender-responsive, and child friendly teaching, physical improvement. The organization has facilitated local governments' education planning and child development strategies re/formation. During the year, it has assisted early childhood development, extracurricular activities, parental education/awareness, and school safety planning and strengthen to create learning environment for the interest of the children.



Under the action of capacity and skill enhancement of teachers and management committees, it has offered training on Gender Transformative and Inclusive Classroom Management to 40 teachers, Inclusive Pedagogy to 40 teachers, and School Improvement Plan (SIP) preparation and updating to 63 School Management Committee (SMC) chairpersons and 10 head teachers. In a total 80 teachers have obtained training on Integrated Educational Management Information System (IEMIS) records updating and trained 16 teachers of eight schools on the ReAL Planning and implementation that benefitted to 500

students. Additionally, the programs have facilitated Secondary Education Examination (SEE ) focused remedial support classes for 36 participants.

and has conducted a survey to identify out-of-school children in four local level of Bajura District that identified 266 out-of-school children. For the purpose of reading habit improvement it has established reading corners in Five schools, 220 households, and book corners in four schools in Bajura.

PeaceWin Nepal has provided training on the preparation and use of Early Childhood Development (ECD) learning materials to 19 ECD teachers. A total 480 parents of 16 groups in the catchment areas of eight schools have been participated in parental awareness programs. Awareness campaigns have conducted for 356 community members on child protection through Child-Led Support Events and awareness campaigns, and contributed into the prevention of 36 child marriages. It has conducted life skills and self-protection training to 124 children, contributing to the improvement of their life skills, confidence, and overall well-being.

During this year calender the programs have facilitated in preparing the Out-of-School Children Procedure to to Triveni Municipality, Bajura. A workshop in Khaptad Chhededaha Rural Municipality to prepare the 10-Year Palika Education Plan and Integrated Child Development Strategy was conducted following the Palika-level education workshop. In this year, the projects have supported Triveni Municipality in developing a procedure of bringing out-of-school children back into the formal education system. A extensive campaign of child marriage-free communities to Malta, Padena, Mallo Sayal, Tallo Sayal, Boharabada, and Belkatya, a total six communities. The organization has supported the implementation of extracurricular activities in 12 schools. The activities conducted in Khaptad Chhededaha Rural Municipality and Budhiganga Municipality encouraged and motivated children to explore, develop, and showcase their hidden talents. It has supported the classroom management of two ECD centers and completed floor sitting in two schools.

### **Continuity in Rohan's Education Through Parental Guidance**

*Rohan Luhar is the youngest son of Bhim Bahadur Luhar and Ujyali Luhar of Budhiganga Municipality - 4, Banegaun, Bajura. His family's income source was from seasonal work in India. They all together are four members in the family, his parents and an elder brother. In search of income opportunity, the family had migrated to India in 2076 B.S. Beside his father all have been returned back in Nepal and his mother aterts retail shop at the village.*

*After returning home, a positive change was seen in Rohan's education. He is currently studying in grade 7 in Bhanodaya Secondary School. Parental education has inspired and convinced his mother to reenroll into school. After a hard effoert of this project action his father returned to the village to support his son's education.*

mother also has participated in parental education sessions. After that, she began visiting the school weekly, regularly discussing her son's progress with teachers and took interest about his learning. Teachers report that Rohan's academic performance is now satisfactory, with a learning achievement level of B. He has been regularly receiving educational materials and uniforms from the project. A study corner has also been arranged at home. His education is now progressing into a right direction.

### **A Courageous Journey Against Child Marriage: The Role of Rekha**

Rekha (name changed), 14 of Dipayal Silgadhi Municipality, Doti was studying in Grade 8. Like many other girls in her community, early marriage was normal, and her family also has believed it as the honor to family and traditions. Her marriage date was announced and made all formal arrangements. For Rekha, this would end of her dream, education, and future life.



She had already felt the painful reality of child marriage in her own family. Her sister was married at 14 and later suffered from violence, and came back to her maternal home, and discontinued her study. This deeply has affected Rekha and made her fear about her life.

Rekha newlywed was 29-years-old, and knowing this she felt helpless and scared. But everything began to change when she joined a school RUPANTARAN sessions under the "Empowered Women, Prosperous Nepal" program implementing in partnership of UNFPA and PeaceWin Nepal. There, she has got awareness on child marriage and gender-based violence, its legal

provisions, social harmful norms, and its future effects.

With a courage, Rekha shared her fear with friends, teachers, RUPANTARAN facilitators, and others. With their support, she raised her voice through the local child club and local level judicial committee. After several discussions with her parents, the marriage was cancelled.

She guessed the moment of life change at the time. Rekha continues her school and completes all sessions of RUPANTARAN and builds up life confidence, skill of leadership, and communication. Now she is the Vice-Chairperson of the Municipal Child Club and has initiated the regular campaigns against child marriage and gender-based violence in her municipality.

In recognition of her work, she was honored during the 16 Days of Activism against Gender-Based Violence 2025. Rekha says, "If I had not joined the RUPANTARAN sessions, I would never have had the courage of cancellation my marriage or understand its effects." Her father with a pride shares his changing consent that the daughter has been becoming as source of inspiration against the child marriage and life safety for other children. Rekha's story shows that when a child gets education, life skills, and community and family support, can challenge to harmful traditions and become change agents.

## Leadership of Women and Youth

This theme focuses on strengthening and engagement of women and youth by establishing and re/forming women/youth groups/clubs and enhancing their management capacity. It enhances the leadership and life skills of adolescents through training, exposures, workshops and behavioral changes, rehabilitation to victims from gender-based violation and abuse. Community awareness on gender-based violence significantly increases through household dialogues and structured outreach activities. The initiatives also improve access to adolescent-friendly and protection services, including referrals to specialized support systems. Overall, it promotes gender equality, women's empowerment, and strengthened community-based safety mechanisms for adolescents and vulnerable groups.

During the project calendar the organization has supported in establishing and reforming 15 youth clubs in Bajura, and providing them sports materials, office management goods to strengthen their functions. The organization has supported positive behavioral changes, resulting in 16 adolescents successfully demarketing from substance abuse. It has implemented multiple interventions for promoting gender equality, women's empowerment, and gender-based violence prevention through social medias, community engagement and capacity building. other social media.



The interventions were conducted on Youth Adoption Training for 30 youths and adolescents to enhance their leadership and life skills. It has facilitated family dialogue sessions reaching to 1,000 households and awareness rising on gender-based violence to 8,675 community members. Ensured access to adolescent-friendly services for 1,587 adolescents through Adolescent Friendly Information Center (AFIC) and supported 30 adolescents to access services from One-Stop Crisis Management Centre (OCMC). The programs have reached to 8,675 community members and 450 adolescents through structured awareness and capacity-building activities. It has benefitted to 1,086 adolescents in referral and support systems for ensuring access to basic protection and crisis services

## Livelihood and Entrepreneurship



PeaceWin Nepal through various programs have supported in new enterprises through start-up initiation along with life skills, business skills, vocational, and entrepreneurship development trainings. Farmers and groups have received seeds, agricultural inputs, and technical support in farming of turmeric, ginger and bee keeping. Capacity-building activities on sustainable farming systems, crop calendar, nutrition, marketing, insurance, kitchen gardening, and tree plantation have been carried. Regular meeting, orientation, and distribution of crop calendars, along with information boards at ward level aware to farmers. Municipalities and

local stakeholders have engaged in promotion of fruits, cash crops instead of cereal crops to save from monkey attack and in promoting agricultural pocket zones where possible. Women- and youth-led organizations were identified, assessed, and formally engaged to strengthen local ownership and sustainability of production.

During the year 2025, the organization has provided start up support to 134 participants of Abha



and UNFPA 9<sup>th</sup> Country Programs. After this support they have stated their entrepreneurship.

The WE-CAN project implementing in partnership of Welthungerhilfe (WHH) of the organization supported seeds/agricultural materials/inputs to 25 local resource persons, and mini-kilts/seeds /agricultural materials to 50 farmer groups to enhance agricultural production in Achham. Similarly, it supported to 12 farmer groups; 3,600 k.g. black pepper (timur) seedlings and 12 bee

keeping sets to nine trained participants to promote sustainable livelihoods and income generation. In the year, 303 events of quarterly meetings, 400 events of 4<sup>th</sup> level sessions of Sustainable Integrated Farming Systems (SIFS), 101 events of orientation on crop calendar, 135 events of Linking Agriculture and Natural Resource Management towards Nutrition (LANN), and 40 events of one day training on tree plantation in Achham have been carried out. The organization has distributed 2500 crop calendars to 2500 households (HHs), and Nine hoarding boards installation in 9 wards. The organization under the project has conducted four events of Two days training on LANN+ to Female Community Health Volunteers (FCHVs). Like as, a 5 days life skill training, a Five days business skill training and a Nine days vocational training for 40 participants in Bajura, and three events of Three days Entrepreneurship and Business development plan training in Achham. Held 101 events of orientation on crop and livestock insurance, 8 events of workshop on innovation for coexistence of human and animal, 50 events of orientation on marketing and market literacy, and 50 events of Two days training on Kitchen Gardening have been employed. The organization has conducted Five events of Five days training on SIFS. Moreover, Three workshops and Five meetings with Municipalities and local representatives to promote agricultural Pocket Zones and identifying probable sites for the SIFS initiation were organized. It has completed Four training events on bee keeping in technical support of Agriculture Knowledge Center, Achham and then assessed, and identified 30 women and youth led community organizations in this business, and made formal contract for further action of production.

## Health, Nutrition and Hygiene



Activities have been implemented across Municipalities and Rural Municipalities to improve health and nutrition of women and children. These has included support for health policy development/improvement, Sexual and Reproductive Health and Rights (SRHR) dialogue, budget planning, social audit, and mentoring on health information systems. Maternal and reproductive health, and family planning services have been strengthened, and improving access to health services of women. Children health check-ups and treatment support were

provided, along with hygiene kits distribution. Community awareness has increased through FCHVs, traditional healers, and community mobilization to reduce harmful practices, like: menstruation hygiene (*Chhaupadi*) and promote dignified menstruation. School-based programs and capacity building of stakeholders has helped to expand SRHR knowledge among adolescents, improving overall health awareness and services.

The organization has facilitated in developing Health Policies in three local level and conducted policy discussion on SRHR policy in Triveni Municipality, Bajura. Moreover, the organization has done follow-up mentoring on Health Management Information System (HMIS), District Health Information Software 2 (DHIS2), Electronic Logistics Management Information System (eLMIS), and Routine Data Quality Assessment (RDQA) in 20 health institutions. Nearly 3,500 women have accessed to essential health services in facilitation of the maternal and reproductive health through regular reviews, mentoring. There have been five Menstrual Health and Hygiene (MHH) Corners established and revitalized 16 MHM Clubs, and supported materials to run clubs. Nutrition Corners in seven health posts have been established. The project has assisted to three municipalities to develop/strengthen health policy, SRHR policy dialogue, and

the leadership of local representatives in planning and budgeting procedure. A Five days capacity building training was conducted for teachers of previously established AFIC schools and the same was established in Five new schools. Budhiganga Health Post, Bajura has developed a health Contingency Plan. Renovation of drinking water facilities and toilets in 10 schools have got financial and technical support of the organization.



It has organized workshops on SRHR budget allocation in eight local levels along with facilitation social audit of 16 health institutions. During the year 18 FCHVs have been mobilized in raising awareness on menstrual hygiene and benefitted 1,430 mothers. Similarly, 1,254 sponsored children and 2,000 non-sponsored children have received health check-up services voluntarily. Traditional healers under the project of the organization have facilitated to 4,542 community members on menstrual hygiene awareness and reducing menstrual stigma. It has implemented extensive awareness campaigns on nutrition, water and sanitation hygiene (WASH), climate change, gender equality, and dignified menstruation. A total 1,704 community healers were mobilized in sensitizing against Chhaupadi system and other harmful traditional social practices. A Comprehensive Sexuality Education (CSE) training was organized and 20 teachers have participated in Bajura. Around 2,500 adolescents through the AFIC initiatives have got capacity building activities including teachers, and key stakeholders on SRHR.

FCHVs have obtained knowledge on family planning services, supply chain management, and community awareness through planning and training.

A child from marginalized community has got health treatment support of NRs. 50,000.00 and rehaved his health. Hygiene kits such as hair oil, nail cutters, combs, glycerin, Vaseline, toothbrushes, toothpaste, and soap containers to 1,254 children to promote personal hygiene have been distributed. In addition, menstrual hygiene educational sessions were conducted to 453 adolescent girls in schools.

### **Education into Action: Increased Use of Long-Acting Reversible Contraception (LARC)**

*Bajura Gaumul Rural Municipality, a review of reproductive health services showed that women had limited knowledge about long-acting family planning methods, especially Intrauterine Contraceptive Device (IUCD). Many women mainly relied on Depo-Provera injection. Fear and misconceptions about IUCD and limited of counseling on options, they have used injecting means.*

*To address this, an awareness program was conducted in the working area of Manakot Health Post. Primarily FCHVs have been oriented with technical support from health posts' staffs, focusing on the benefits, safety, and proper use of IUCD and other LARC methods. This has helped them sharing clear information confidently in the community.*

*After the orientation, FCHVs have conducted regular discussions with mothers' groups in their respective wards/communities. These have addressed to avoid myths, reduced fears, and encouraged women to visit health facilities for counseling and services. As a result, women have started visiting the health post and choice IUCD as a safe and reliable family planning option. This significantly improved the use of LARC methods and helped women to build confidence on reproductive health decisions.*

## Good Governance, Human Rights, and Democracy



PeaceWin Nepal promotes transparency, accountability, human rights, and democratic practices at all levels of organization development and program implementation through its governance-focused initiatives. Through its programs, PeaceWin Nepal works to ensure equality, fairness, inclusion, participation, and representation for individuals and community by safeguarding and promoting human rights. PeaceWin Nepal has supported the re/formation of Child Rights Committees at the local level in Bajura. It has also assisted Rural/municipalities in developing and revising child rights procedures to strengthen child protection systems and Child Friendly Local Governance (CFLG). Complaints Response and Hearing Mechanisms (CRM) have been established and strengthened in schools to ensure proper response to child-related issues. In addition, ward-level Child Rights Committees have been re/formed, and members have been trained on their roles and responsibilities, enhancing their capacity to protect



and promote child rights at the family, school and community. The organization in the year has facilitated to re/form Child Rights Committees of Four local level. Triveni Municipality, Khaptad Chhededaha Rural

Municipality and Gaumul Rural Municipality have developed Child Rights Procedure and Budhiganga Municipality, and Badimalika Municipality amended this procedure. The technical and financial support has been provided to 15 schools' CRMs strengthening. Formation of Child Rights Committees (CRCs) in eight wards and 110 CRC members have been enhanced their capacity through training and workshops.

## Disaster preparedness and physical Safety



Suspension bridges have been constructed in different local levels of Bajura to improve safe movement to children to their schools, reducing farmers' time to fetch water from near by spring water (crossing river/stream), collecting daily use goods from forest, and farms. Disaster Risk Reduction (DRR) and school safety activities were conducted with the participation of community members, and school safety plans were updated in selected schools of Khaptad Chhededaha Rural Municipality and

Budhiganga Municipality. Digital safety awareness was carried out in schools to students and teachers. Support has been provided in school building maintenance in Bajura. In Achham, training on tree plantation has been conducted for soil erosion control and environmental preservation, and reduce land degradation. The organization has provided technical and social mobilization support in five suspension bridge construction in Bajura and 11 are under construction. DRR awareness and preparedness activities have been launched and 5116 (male: 2310 and female: 2806) participated in schools. The organization has facilitated to Nine schools to update and reform their school safety plans of Khaptad Chhededaha Rural Municipality and Budhiganga Municipality. Child-friendly and disaster friendly classroom management has been supported to Bhimeswari Basic School, Devestali Secondary School of Khaptad Chhededaha Rural Municipality, Bajura. With incorporating the school safety plans, 14 schools have updated their SIP in facilitation of the organization. During the year 356 participants have participated in digital safety sensitization events from 11 schools. Similarly, Seven schools have got technical and financial support in building maintenance from the projects of PeaceWin Nepal. Farmers of Achham have got training on fodder tree, Napier grass plantation and to control soil erosion through 40 events of activities.

## Monitoring and Evaluation

To guide project monitoring processes, Terms of Reference (ToR) were developed and implemented. Internal and joint monitoring teams conducted field visits and collected information through observations, interviews, focus group discussions (FGDs), and document reviews. Based on the findings, monitoring reports were prepared and shared. Joint monitoring was carried out in close coordination with local government leadership, heads of relevant sectoral departments, the Provincial Health Training and Supply Centre and Sudurpashchim Province Research and Training Academy (SPRTA), Dipayal. The Programme Manager presented all internal and joint monitoring reports, along with the findings and recommendations from internal and final audits, to the Executive Committee for review. Based on these reports, the Executive Committee provided strategic guidance, recognizing good practices that should be continued while also recommending corrective measures and areas requiring further improvement. PeaceWin Nepal also completed its Annual Audit and Social Audit within the stipulated timeframe.



The Executive Committee, Programme Manager, Project Coordinators and Supervisors regularly monitored project implementation on a monthly basis and provided recommendations for continuous improvement. Likewise, the Administration and Finance teams conducted monthly, quarterly, semi-annual, and annual monitoring of both field activities and project documentation. Immediate feedback and on-site technical support were provided to address identified gaps and strengthen compliance with organizational policies and procedures. During 2025, all projects were monitored through both internal and external mechanisms. Regular review meetings, including monthly, semi-annual, and annual reviews, were conducted to assess implementation progress, identify challenges, and agree on corrective actions.

Annual project plans were endorsed by the respective local governments through their municipal or rural municipal council meetings before implementation. PeaceWin Nepal developed corrective action plans based on the findings and recommendations of monitoring reports. To strengthen accountability and ensure effective stakeholder engagement, the organization maintained accessible grievance and feedback mechanisms, including the Child Helpline (1098) for child protection concerns and a toll-free Complaint Response Mechanism (CRM) hotline (16609754000) for project-related complaints, feedback, and suggestions, in accordance with the organization's CRM Manual. During 2025, a total of 44 complaints, feedback submissions, and inquiries of various types were received through these mechanisms. As none of the cases were classified as serious, all concerns were addressed and resolved through telephone communication in a timely manner. Furthermore, recommendations received from monitoring visits conducted by local governments were incorporated into subsequent planning and implementation processes to improve project quality and effectiveness.

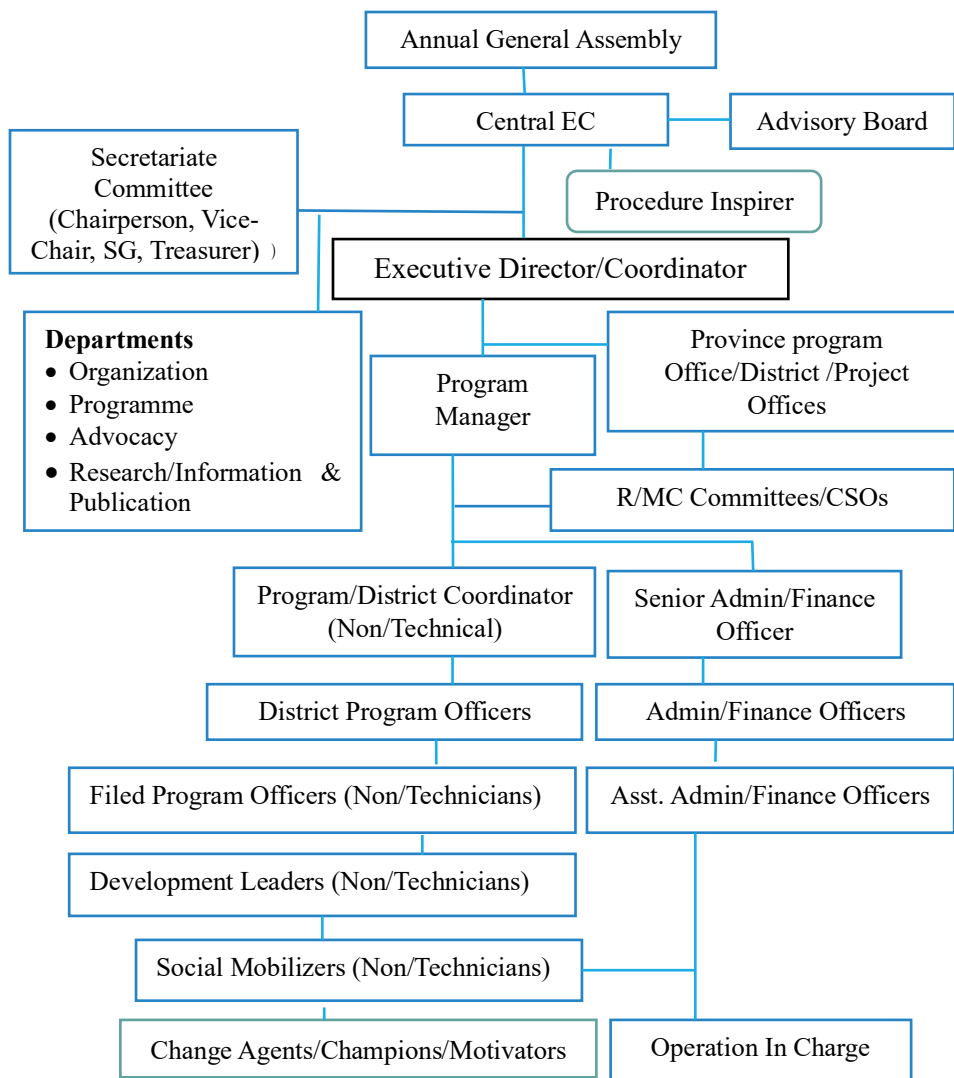
